ADVERTISEMENT FOR SENIOR RESIDENTS (NON- ACADEMIC)

All India Institute of Medical Sciences, Bhubaneswar has been established as an Autonomous Institution and Institute of National Importance through the All-India Institute of Medical Sciences (Amendment) Act, 2012. By virtue of this Act, the Institute grants its own medical degrees and other academic distinctions.

AIIMS, Bhubaneswar invites online applications from Indian Citizens as per Govt. of India, Residency Scheme, 1992 for the post of Senior Residents (Non - Academic) for the tenure Period of 03 years.

The vacancy position in various departments categories are depicted in **Annexure-I**.

A. Eligibility Criteria:

- For Educational Qualification: **Refer to Annexure-I.**
- **To be eligible for selection** for these posts, the candidates should pass the qualifying examination by 30.11.2025 & result should be declared to this effect on or before this date. The tenure of qualifying degree should also be completing latest by 30.11.2025.
- **Only those candidates** who have been/are declared successful in their qualifying degree exam/viva i.e. **DNB/MD/MS/ DM/MCh (as applicable)** and will be completing their tenure for the same on or before **30.11.2025** will be eligible to be considered for these posts.
- In case of those who have appeared for exam/viva voce and result is yet to be declared then applicant will be allowed to appear in theory and/or interview provisionally. However, Result should be available by **30.11.2025**.
- In cases where result of qualifying exam is declared after **30.11.2025**, their candidature will stand cancelled and no claim for selection on the basis of theory exam and Interview allowed provisionally will be considered.
- Compulsory days of Tenure: - 1095 days for MD/MS/MDS/DM/MCh degree; 730 days for secondary DNB degrees.
- Medical Registration is mandatory before joining, if selected.
- Those who have **completed 3 years Residency** under Central Residency Scheme **are not eligible** to apply.

- Total tenure of Senior Residency (Non-Academic) is 3 years. This includes any period spent as a Senior Resident (Non-Academic) in the same specialty in any other teaching institution prior to joining AIIMS, Bhubaneswar.
- **The candidates who are in service in any Govt. Hospital/ Institutions are required to submit their application through proper channel only. The candidates will not be permitted for Interview if they fail to produce no objection certificate on the day of interview during scrutiny of documents. They may be allowed provisionally only if they produce a certificate of informing to the HOD/Head of Organization of Institute in which they are employed.** If it is brought to the notice of authorities at any stage that the candidate had not submitted application through proper channel, then candidature will stand cancelled and in case of selected candidate, services will be terminated immediately.

B. Age limit:

The upper age limit for applying these posts is **45 years** on the last date of application. (Authority: Ministry of Health and Family Welfare Letter U.12016/10/2019-ME dated 02/01/2020)

C. Pay Scale

Rs. 67,700/- as per 7th CPC, Level -11 of the Pay Matrix + NPA plus other usual Allowances as admissible under rules.

D. Reservation of posts

- The reservation for OBC/SC/ST/EWS candidates is as per Central Govt. rules and 4% for PWBD including OPH candidates (on horizontal basis).

- **Criteria for Persons with Bench mark Disabilities (PWBD):**

The disability certificate should be signed by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions & countersigned by Medical Superintendent/CMO/Head of Hospital/Institution.

4% seats are reserved on a horizontal basis. However, the candidate shall be allowed to join only after medical fitness certification by duly constituted Medical Board. The candidate must possess a valid document certifying his/her physical disability is conforming to judgment of Supreme Court of India. The constitution of the Medical Board will include consultants from related disciplines.

- For OBC Candidate: Candidates must attach certificate valid for the posts under the Central

Government of India which mentions that the Candidate does not belong to Creamy Layer.

Date of issue of Certificate should not be earlier than 1 year from the last date of submission of Application Form. Failing which, he/she will not be allowed to appear for interview in the same category. However, he/she can be treated as UR candidate.

- Candidates applying in EWS category must possess a valid EWS certificate in Hindi/English Language issued by the competent authority for admission/jobs in central government institutions. EWS certificates must have issued on or after **01.04.2025 to the last date of submission of Application Form** and be valid for **financial year 2025-26**.
- SC, ST, Certificate should be issued by authorities prescribed by Govt. of India.
- *Language of Certificate should be in Hindi/English Language and in prescribed format for central Government.

E. Selection Procedure for Senior Resident (Non-Academic):

- The candidate can apply for more than one post (**Maximum 03 departments**) out of the enlisted Departments as per Annexure-1 separately but, they have to apply separately for different posts/Departments. However, the candidate will have to deposit application fee separately for each post. No TA/DA will be paid to attend the Interview. Any paid fee can't be claimed later.
- Written examination will only be conducted when number of applicants are **more than three times** than the number of posts advertised. However, there will be no written test for the post against which less number of applications are received than the vacancies. The Executive Director, AIIMS, Bhubaneswar will have the discretion to decide for which post written examination to be conducted and for which post there will be no written examination. The decision thereof will be final.
- The merit list (selected and waiting list) for all categories i.e. UR / EWS / OBC / SC / ST shall be prepared on the basis of combined marks of written test and personal interview or only Personal Interview.
- Any vacancy arising because of non-joining by selected candidates in this selection or by resignation of candidates, post will be offered to the candidates from waiting list according to the merit panel. All applicants must provide latest mobile numbers and e-mail for timely communication.
- For qualification /Reservation /Selection Procedure/Emolument/date of Interview and other latest details, candidates are advised to visit AIIMS, Bhubaneswar website regularly.
- Selected Candidate will be expected to stay in Institute Campus if offered residential accommodation.

F. Application Procedure

- **Candidates who are fulfilling the eligibility criteria must apply through online mode only by visiting Website: aim**
- **sbhubaneswar.nic.in (under Recruitment > Recruitment Notice> Online Recruitment). Failing which, the application/s will be rejected and No further communication will be entertained.**
- The applicants shall upload the scanned copies of the following original certificates to online form mentioned above:

Note: Candidates are advised to download the filled application form along with the fee receipt after submission of application. The same to be submitted at the time of document verification/Interview.

G. Terms & Conditions

Canvassing information of any kind will lead to disqualification, incomplete applications will not be considered and will be REJECTED. No interim correspondence shall be entertained.

- The prescribed qualification is minimum and merely possessing the same does not entitle any candidate for selection.
- The appointees shall be granted leave in accordance with the instructions issued by the Government of India from time to time.
- Private practice of any type is strictly prohibited.
- He / She may work in shifts and can be posted at any place in the Institute or Institute Satellite Centre (Balasore) as per the discrimination of the Competent Authority.
- He / She is expected to abide by the rules of conduct and discipline as applicable to the Institute employees.
- There is no provision displaying marks of Written/Interview for rechecking and no query in this regard will be entertained.
- The candidate should not have been convicted by any Court of Law.
- In case, any information given or declaration by the candidate is found to be false even after selection / appointment or if the candidate has wilfully suppressed any information relevant to this appointment, he/she will be liable to be removed from the service and action will be taken as deemed fit by the Competent Authority.
- **The decision of the Competent Authority regarding selection of candidates will be final and no representation will be entertained in this regard.**
- **Executive Director, AIIMS, Bhubaneswar reserves the right to cancel the advertisement at any point of time without assigning any reason there of or fill up less / more number of posts as advertised depending upon the Institutional requirements.**
- The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice.
- All disputes will be subject to jurisdictions of High Court, Cuttack (Odisha).
- **Candidates working in Govt. / Semi-Govt., PSU should apply through proper channel. The candidate's in-service, if selected will not be permitted to join, without "No Objection Certificate" from the employer. In this connection, it is mentioned that as per the terms and conditions of Central Residency Scheme, their engagement is to be regulated as per the CCS (Temporary Service Rules).**

- The cut-off date to determine the maximum age limit, essential qualification & experiences will be the last date of submission of application form.
- **On selection, the candidates will be given 21 days' time to join the post at AIIMS, Bhubaneswar. In exceptional situations (with reasonable justification) extension may be granted by the Competent Authority for a period of 14 days. No further extension will be permitted thereafter.**
- If any candidate, who joins the post and leaves/resigns/gets terminated before the completion of the tenure, he/she may do so by giving one month's prior notice which will be from either side as per the rules or by depositing pay and allowance in lieu thereof with the Institute for the period of which notice period falls short of one month or so.
- The post will be on tenure engagement for a period of maximum up to 03 (three) years including such engagement earlier if any (if already served as Senior Resident in previous appointments, the same will be calculated along with the present engagement at AIIMS, Bhubaneswar). However, the performance will be reviewed by a committee duly constituted by the Executive Director on completion of 01 year tenure on every occasion and further extension beyond 01 year or 2nd year will be based on the recommendations of the said review committee. In case the performance is not satisfactory, then further extension will not be considered.
- *All eligible applicants, irrespective of their category, may also be considered for the seats advertised under one of the reservation categories. In case of non-availability of candidates in the reservation category in which the seat has been advertised, the candidates belonging to other categories including Unreserved will be considered for appointment not exceeding beyond 44 days, which can be extended further by the competent authority, strictly as per the guidelines issued by the Government of India guidelines in this regard.*

TERMS AND CONDITIONS

1. The appointment is purely on TEMPORARY BASIS for **44 days or till 03-year (tenure) appointment** to the post is made or till further orders, whichever is earlier. If the contract is not extended further, the same will lapse automatically.
2. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
3. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits available to the Government Servants, appointed on regular basis.
4. The appointee shall not be granted any claim or right for regular appointment to any post of AIIMS, Bhubaneswar.
5. The appointee shall be on the whole-time appointment of the AIIMS Bhubaneswar and shall not accept any other assignment, paid or otherwise and shall not engage himself/herself in a private practice of any kind during the period of contract.
6. The appointment to the said post will be subject to medical fitness from the competent medical board for which he/she will be sent to the designated Medical Authority.
7. The appointee is entitled for **03-days** leave during **44-days** temporary engagement.
8. The appointee is not entitled to any T.A. for attending the interview and joining the appointment.
9. Other conditions of service will be governed by relevant rules and orders issued from time to time.
10. If any declaration given or information furnished by him/her proves false or if he/she is found to have wilfully suppressed any material, information, he/she will be liable for removal from service and also such other action as the Government may deem necessary.
11. The appointee shall not be entitled to avail any allowances/facilities being extended to the regular/permanent faculty members of the AIIMS, Bhubaneswar.
12. The AIIMS, Bhubaneswar reserves the rights to increase or decrease the number of vacancies.
