Western Coalfields Limited (A Mini Ratna Company) is a subsidiary company of Coal India Limited, (A Government of India enterprise, functioning under the Ministry of Coal), invites application for engagement of Apprentice Trainees against the Opportunities created for Degree/Diploma /ITI Trades/Matriculate certificate holders. The duration of Apprentice Training shall be One year (12 Months) from the day of engagement as Apprentice Trainee. The mode of application is online by utilizing the dedicated portal available on the website of WCL i.e. www.westerncoal.in which can be assessed following the path:-

Home Page>Career>Apprentice.

For Graduates and Diploma Apprentice Positions applying candidates must enroll themselves on the 'National Apprentice Training Scheme' (NATS) web portal i.e. <https://nats.education.gov.in> & Candidates applying for Trade Apprentice positions must enrol themselves on National Apprentice Promotion Scheme (NAPS) web portal i.e. <https://www.apprenticeshipindia.gov.in>.

Candidates are advised to go through the following provisions provided in detail before applying:-

1. Who can apply:

- Only Indian national who have 'either' passed their requisite qualification, as prescribed under **Table 1**, corresponding to the applied opportunity, from any recognized Institute/ University which is either functional and operational in Madhya Pradesh/Maharashtra, 'or' who is a permanent resident of Maharashtra State /Madhya Pradesh State, are eligible to apply, whereas the residency shall be verified against the Permanent Domicile Certificate of the applying and claiming candidates beside fulfilling other criterion as prescribed under the Notification.
- However, applying candidates must be aware of the criterion that for Trade Apprentice positions the candidates who are the residents of the district (in respect of each of the establishments) where the establishment head office is functional shall be preferred.

The candidates are required to submit a Disability Certificate issued by competent authority as per the Rights of Persons with Disabilities Rules, 2017 failing which their candidature as PwBD candidates will not be entertained. The format for disability certificate has been enclosed as **Annexure - 2**

5. Beside fulfilling the desired qualification, the residency of a particular district where the establishment is functioning, the caste category for claiming the reservation the parallel eligibility and applicable terms and requirements are as follow:

(A) Other Eligibilities and Prerequisite:

i. Age Criteria :

- a) Minimum 18 years and maximum 26 years as on the Cut-off date i.e. **01/08/2025**. That is, the Candidate/Applicant should have born on or in between 02/08/1999 to 02/08/2007

b) Age Relaxation:

- a) Upperageisrelaxedby5yearsforSC/STcandidatesand3yearsforOBC-Non-CreamyLayer candidate for the Slots/Seats reserved for them.
b) Candidates belonging to PwBD categories shall be given age relaxation up to 10 years (up to15years for SC/ST and up to 13yearsforOBC(Non-Creamy Layer)Candidates)

ii. Applying candidates should have passed his/her Graduation/ Diploma or ITI (NTC) as desired under Table 6, during or after the academic Year 2022-23.

- iii. Calculation of Passing Percentage: The Matriculation (10th Standard)/degree/ diploma/ National or State Trade Certificate passing percentage as provided by university/Board/ Council/college/ Institute will be considered or where CGPA/GPA or letter grade in a qualifying degree is awarded, equivalent percentage of marks should be indicated in the application form as per norms adopted by University/Institute/Board/Council and that has to be mentioned up to two decimal points. Candidates are advised to obtain a certificate to this effect from University / Institute/Board/Council etc., which shall be required at the time of assessment of eligibility before joining as Apprentice in WCL. Rounding off will not be considered, i.e. 49.99% will be treated as less than 50%. In the application form the candidates are required to mention the total marks scored and the maximum marks separately. In case of CGPA/GPA or letter grade candidates must mention their equivalent percentage against the maximum score of 100.

- iv. For all positions(Except the opportunity in Security Guard optional trade): The candidates must possess the desired qualification as per the applied post as prescribed under Table 1, from a recognized University/Institute **by passing a full time regular course in relevant disciplines of Graduation/Diploma or Trades of ITI**. Qualification as prescribed under 'Table 1' acquired through Part-time / Correspondence / Distance Learning mode shall render the candidate ineligible.

v. The candidates who have undergone Apprenticeship earlier or pursuing Apprenticeship Training in an Industry as per the Apprenticeship Act (as amended from time to time) 'or' having job experience of 1 year or more are summarily ineligible for the Apprentice Positions.

- vi. In case the date of Declaration of result is not mentioned in the Mark Sheet, the candidate must submit a certificate mentioning the date of publication of result from the Principal of the College/Institute from where the candidate pursued his course at the time of the scrutiny of original documents.
vii. Candidates possessing higher qualification over and above the prescribed qualification shall not be considered eligible for the above notified positions.
viii. Candidates willing to apply against the Optional Trade opportunity created in **Security Guard Trade** must understand that **they are required to fulfil the following physical parameters beside fulfilling the other eligibility criteria:**

- a. Height, 160 cms (Female 150 cms), weight according to standard table of height and weight, chest 80 cms with an expansion of 4 cms (for females no minimum requirement for chest measurement).
- b. Eye sight: Far sight vision 6/6, near vision 0.6/0.6 with or without correction, free from colour blindness
- c. Free from knock knee and flat foot
- d. Hearing: Free from defect

(B) Selection Methodology:

- i. A candidate may apply against any one of the notified positions pertaining to anyone of the establishments only. Multiple applications will lead to disqualification of the candidature.
- ii. Candidate shall be wholly/exclusively responsible for the information provided in his/her online application form and if at any stage of selection it is revealed or found that the candidate has just furnished incorrect information while applying online his/her candidature shall be rejected with immediate effect.
- iii. Information pertaining to date of Birth, Caste Category, Qualification etc. once entered in the Online Application shall be considered as Final and no alteration will be permitted at later and subsequent stages, that is why the candidates must check and be assure about the correctness of the information filled/applied under Online application before finally submitting it online.
- iv. **The methodology for drawing Merit of the respective disciplines of Graduation/Diploma & Trade has been furnished below:**

The candidates under merit shall be arranged in the decreasing order of average Marks scored (i.e. average of his/her passing score in Matriculation and Trade Certificate) keeping the highest scorer at the top and the lowest scorer at the bottom of the merit.

- v. Provisional Short listing of Candidates for Scrutiny of Original Documents before joining as Apprentice Trainee will be done on the basis of the merit drawn wherein the number of shortlisted candidates will be 1.5 times to the notified opportunities in respect of different caste categories i.e. SC/ST/OBC/UR. WCL reserves the right to restrict the number of candidates to be called for scrutiny of original documents before offering an opportunity to pursue Apprentice Training. **The short listing will be done on the basis of the information as submitted/declared by the candidates over WCL-Online application portal and the candidature shall be liable to be rejected if it is revealed during the scrutiny that he/she had applied with incorrect /wrong information in regard to his/her qualification or passing percentages.**
- vi. The candidates shall have to appear along with all original certificates/documents as per eligibility criteria notified in this Notification for scrutiny. The date and venue for scrutiny shall be notified in the official website of WCL i.e. <https://westerncoal.in> and the candidates shall have to report accordingly.
- vii. In the event of failure to report with all original certificates and testimonials within the stipulated date and time, the candidature of such candidate shall stand cancelled.
- viii. A tie in the score shall be resolved firstly by the DOB by preferring the candidate who have born earlier and secondly if, tie remain unresolved, it shall be resolved by preferring such candidate who have scored higher in his/her matriculation examination.
- ix. Final offer for Apprenticeship Training would be subject to clearing the Medical Test as per the prescribed Form O, standards as prescribed under the Mines Rules 1955. It is mandatory to obtain a fitness certificate from the establishment's (WCL) medical officer. The prescribed format for medical fitness has been enclosed herewith for reference as **Annexure -3**. The Photograph of the candidate should be pasted on the medical examination form, which should be signed and stamped by the examining medical officer. Medical fitness certificate in any other format other than the specified will not be entertained and the contract of Apprentice training shall be issued only after ensuring the medical fitness of the applying candidates in prescribed "Form O".
- x. The apprenticeship contract will be generated through NATS/NAPS portal, and the same has to be accepted by the Candidate. (C) Requirement before filling the online application form.

- i. For Graduates and Diploma Apprentice Positions applying candidates must enrolled themselves on the 'National Apprentice Training Scheme' (NATS) web portal i.e. <https://nats.education.gov.in> & Candidates applying for Trade Apprentice positions must

enrol themselves on National Apprenticeship Promotion Scheme (NAPS) web portal i.e. <https://www.apprenticeshipindia.gov.in>.

- ii. After successful registration with the NATS/NAPS portal, a registration number (Enrolment ID) will be generated and the candidate has to mention this registration number while applying for apprentice position through WCL website link.
- iii.
